# **Message from the President**

In view of the COVID-19 crisis, our College has started to arrange CME activities via videoconferencing as one of the contingency measures during this period. I am delighted to report that judging by the enrollment numbers and feedback we have received thus far, they have been highly successful and very much welcomed by our College members. Please stay tuned for more of these to come via the usual College communication channels.

The HKCFP Research Committee has conducted an online survey on 31 January 2020 among our doctor members to identify the preparedness of family doctors in providing clinical care during the initial stage of COVID-19 outbreak. Of the 491 (30.9% response rate) family doctors who completed the online survey, 246 (50.1%) doctors worked at public primary clinics, 242 (49.3%) doctors worked in the private sector while 3 (0.6%) worked in both sectors. The vast majority of the surveyed family doctors continued to provide regular primary care services to the public although many (428, 87.2%) reported that their clinical practice had been affected by the COVID-19 outbreak. Six (2.5%) private doctors had to close their practices.

The survey found that within 10 days of the first confirmed COVID-19 case in Hong Kong, over 140 patients with suspected COVID-19 presented to 70 participating family doctors, and one patient was confirmed to have the infection. Hence, family doctors are at the very first point of professional contact of COVID-19 patients. Most doctors responded to the outbreak with heightened infection control practices, but the main concerns were great difficulties in securing personal protective equipment (PPE) supplies, the lack of rapid diagnostic test, training demands on



COVID-19, the need to enhance co-ordination of the roles and responsibilities between the public and the private sectors, and more effective public health policy to contain the outbreak. Many requested for setting up of designated clinics to help manage the crisis.

Since 70% of primary care consultations take place in the private sector locally, it would be crucial to involve private family doctors, who are one of the major community stakeholders, in the fight against outbreaks such as COVID-19 as part of the overall health system strategy and emergency response.

The family doctors in the community are willing and ready to help out and play our parts in the combat against COVID-19! Let's work together to fight against COVID-19!

On a more global perspective, the New England Journal of Medicine recently published an article by Mr. Bill Gates entitled "Responding to Covid-19 – A Oncein-a-Century Pandemic?" (https://www.nejm.org/doi/ full/10.1056/NEJMp2003762), discussing solutions for both the current crisis caused by COVID-19 and

the long-term strategies to prevent and tackle possible outbreaks in the future. Mr. Gates argued that health systems could easily be overwhelmed by a pathogen like COVID-19, especially the primary health care systems. On the other hand, he went on to reiterate that having trained health care workers in a strong primary health care system could help in immunization, monitoring disease trends and becoming a system beacon to alert the government about potential outbreaks. This, coming from a person with non-clinical background, is surprisingly matching with the clinical perspectives. In fact, having a well prepared and strong primary health care work force with well-trained family doctors would be one of the essential elements to prevent recurrence of potential future pandemic diseases; actually this applies when the community is "in sickness and in health".

From the Budget speech of 2020-21 announced on 26 February 2020, resources and funding would be earmarked for Government's health projects including the promotion of primary healthcare services. Additional funding would be provided to support anti-epidemic efforts and enhance medical training in general. Subsidies would be allocated for setting up of interim "District Health Centre (DHC) Express" by non-governmental organisations in 11 districts. However, we are still looking forward to the Government's actions in allocating more resources to training of family physicians in Hong Kong, which as illustrated above would lead to an even stronger primary health care system to address the ever increasing needs in the community.

## THIRTY-FOURTH CONJOINT HKCFP/RACGP FELLOWSHIP EXAMINATION THIRD (FINAL) Announcement

The Board of Conjoint Examination is pleased to announce the following information on the Thirty-fourth Conjoint Fellowship Examination with the Royal Australian College of General Practitioners to be held in 2020.

## (1) REQUIREMENTS AND ELIGIBILITY

All candidates **MUST** be FULL OR ASSOCIATE members of BOTH HKCFP AND RACGP\* at the time of application for the Examination and at the time of the Conjoint Examination.

(\*Documentary evidence is required with the application – including a valid RACGP number.)

(**Note** : All candidates are required to renew their RACGP membership for the year 2020/2021 before 31 July 2020. Failure to comply with the rule may result in denial of admission to the Exam.)

In addition, they must be EITHER CATEGORY I OR CATEGORY II CANDIDATES: -

(a) CATEGORY I CANDIDATES are graduate doctors (FULLY OR LIMITED registered with the Hong Kong Medical Council) who are undergoing or have completed a fully approved vocational training programme as outlined in the College's Handbook for Vocational Training in Family Medicine.

After satisfactory completion of two years of approved training, Category I candidates or trainees may apply to sit the Written Examination, both the two segments of which must be taken at the same attempt. After satisfactory completion of four years of supervised training, Category I candidates may apply to sit the Clinical Examination.

**(Note:** For Category I candidates who have enrolled in the vocational training programme before 31 December 2018, and who apply for the award of RACGP Fellowship before 1 March 2027, they will remain entitled to be awarded FRACGP. All other candidates are eligible to apply for the award of International Conjoint RACGP Fellowship (ICFRACGP).

All Category I candidates who are current vocational trainees and apply to sit the Written Examination **MUST** submit evidence of completion of at least 15 months of approved training by 31 March 2020, together with the application. Those current vocational trainees who apply for the Clinical Examination **MUST** submit evidence of completion of at least 39 months of approved training by 31 March 2020, together with the application. Candidates who have already completed vocational training **MUST** submit evidence of completion of vocational training, together with the application.

Part-time trainees must submit evidence of completion of their vocational training by the time of the Written Examination before they can apply to sit the examination.)

(b) CATEGORY II CANDIDATES are doctors who are FULLY registered with the Hong Kong Medical Council and have been predominantly in general practice in Hong Kong for not less than **five** years by 30 June 2020. Category II candidates may opt to only sit for the Written Examination at the first and subsequent application. Enquiries about eligibility to sit the examination should be directed to the Chairman of the Board of Conjoint Examination.

# The eligibility of candidates of both categories is subject to the final approval of the Board of Conjoint Examination, HKCFP.

## Application will not be processed unless all the documents are submitted with the application form.

## (2) FORMAT AND CONTENTS

- A. Written Examination
   Applied Knowledge Test (AKT)\*, and
   Key Feature Problems (KFP)
   \*Note: Multiple Choice Questions (MCQ) has been renamed as Applied Knowledge Test (AKT) from Conjoint Exam 2018, with
   no major change on the exam format.
- B. Clinical Examination Objective Structured Clinical Examination (OSCE)

## (3) PRE-REQUISITE FOR CLINICAL SEGMENTS

All candidates applying to sit for the Clinical Examination of the Conjoint Fellowship Examination MUST possess a APCLS (Advanced Primary Care Life Support) certificate issued by the HKCFP\*. The validity of this certificate must cover the time of the Clinical Examination.

Application will not be processed unless the pre-requisite is fulfilled.

\*Note: In regarding the APCLS certificate as issued by the HKCFP, the dates of APCLS workshops & examinations for 2020 will be confirmed shortly. Please register with our College secretariat at 2871 8899 IMMEDIATELY if you do not hold a valid APCLS certificate issued by HKCFP and intend to sit for the Conjoint Examination 2020.

## (4) CRITERIA FOR A PASS IN THE EXAMINATION

A candidate will be required to pass the entire Written Examination in one sitting. That is, if one fails the Written Examination, both the AKT and KFP segments have to be re-taken. Successful Written Examination result can be retained for three years (until the Clinical Examination of 2023).

The Clinical Examination can only be taken after successful attempt of the Written Examination. If one fails the Clinical Examination, all the OSCE stations have to be re-taken.

A candidate has to pass both the Written and the Clinical Examinations in order to pass the Conjoint HKCFP/RACGP Fellowship Examination.

## (5) APPLICATION AND EXAMINATION FEES

You may also download the application forms from our College website, http://www.hkcfp.org.hk. Please note that the deadline for application is **8 April 2020 (Wednesday)**.

If a candidate wishes to withdraw from the examination, and written notice of withdrawal is received by the College 60 days or more prior to the date of the examination, he / she will receive a refund of \$31,000 (for the whole examination), \$15,500 (for the written examination) or \$15,500 (for the clinical examination). The application fee of \$3,000 will not be refunded.

No refund will be given if the written notice of withdrawal is received by the College within 60 days of the date of the examination.

All fees paid are not transferable to subsequent examinations.

# Diploma in Family Medicine (HKCFP) 2020 - 2021

The Board is pleased to announce that the Diploma Course in Family Medicine (DFM) organized by The Hong Kong College of Family Physicians will commence in July 2020.

The course consists of FIVE modules. Modules I & II will be delivered by Local Distance Learning. Modules III, IV & V consist of lectures, seminars, tutorials, workshops and clinical attachments. The whole course requires ONE year of part-time studies.

Details of the course are as follows:

### 1. Objectives:

- i) To provide knowledgeable, pragmatic and structured teaching in Family Medicine for medical practitioners
- ii) To encourage professional development of practising medical practitioners and to provide an intermediate step to fellowship qualifications in Family Medicine
- iii) To improve standards and quality in the practice of Family Medicine

#### 2. \*Syllabus:

- The course consists of FIVE compulsory modules. Doctors who have graduated from the course are expected to have acquired:
- i) Current concepts about nature of Family Medicine
- ii) Knowledge and skills in consultation, counselling and problem solving
- iii) Knowledge and skills in common practice procedures and emergency care required for good quality family practice
- iv) Understandings towards the role of Family Doctors as gatekeepers of the health-care system and in providing cost-effective primary care to the community

#### Module I – Principles of Family Medicine (Distance Learning)

Aims:	<ol> <li>Learn concepts of Family Medicine</li> <li>Understand the role of a Family Doctor and scope of Family Medicine</li> </ol>		
Contents:	Definition of Family Physicians, Family Physicians' Functions, Core Values of Family Medicine, Consultation, Future of Family Medicine		
Module II – Common Problems in Family Medicine (Distance Learning)			

Aims	<ol> <li>Enhance consultation, communication and problem solving skills</li> <li>Understand the diagnostic formulation process in Family Medicine</li> </ol>
Contents:	Four clinical scenarios. Each clinical scenario further divides into several questions covering different areas in general practice

### Module III - Essentials of Family Medicine (Structured Seminars and Tutorials)

Aims:	<ol> <li>Strengthen knowledge in Family Medicine</li> <li>Understand the potential growth of Family Medicine</li> <li>Develop research and teaching skills in Family Medicine</li> </ol>
Contents:	Practice Management, Care of Elderly, Chronic Disease Management, Anticipatory Care, Clinical Audit & Research, Mental Health, Musculo-skeletal Problems, Evidence Based Medicine & Critical Appraisal

#### Module IV - Clinical Updates (Updates and Clinical Attachment)

Aims:	Acquire in-depth knowledge and practical skills in selected specialties
Contents:	THREE update seminars plus ONE attachment in selected specialty

### Module V - Practical Family Medicine (Practical Workshops)

Aims:	Enhance practical and communication skills in Family Medicine by Practical Workshops in selected areas including CPR, Consultation Skills, Counselling Skills, Women's Health, Orthopaedic Injection and Musculo-Skeletal Medicine
Contents:	Four compulsory and two elective Practical Workshops in selected areas including Advanced Primary Care Life Support [APCLS]. Consultation Skills, Counselling Skills, Women's Health, Orthopaedic Injection and Musculo-Skeletal Medicine

Module III & V will be scheduled in Saturday and Sunday afternoons.

#### 3. Articulations:

The Course allows (up to a fixed maximum percentage of the Course units) articulations or cross recognition of previous Family Medicine training programmes that provide learning units equivalent to that of the above syllabus. Participants who wish to apply for such articulations have to submit evidence of relevant training together with their applications. The granting of articulations is however, completely at the discretion and decision of the Board of DEM

#### 4. \*Schedule:

The whole course requires ONE year of part-time studies.

#### 5. Admission Requirement:

Medical Practitioner with Bachelor's Degree in Medicine.

#### 6. Teaching Staff:

A panel of experienced academic medical professionals in Family Medicine, hospital specialists and experienced Fellows or Trainers of HKCFP will be invited to teach in the programme.

### 7. Teaching Medium:

### English

(Cantonese may be used in some seminars, workshops and clinical attachments)

- i) A Diploma in Family Medicine issued by HKCFP will be awarded to candidates who have satisfied all the requirements and have passed all the required assessments and the Final Examination.
- ii) The Diploma is a **Quotable Qualification** of The Medical Council of Hong Kong.
- iii) Up to 50 CME and 10 CPD credit points will also be awarded to candidates at satisfactory completion of the Course by the QA & A Committee of HKCFP.

### 10. Application Procedure:

### Applications are now open.

A completed application form must be returned to The Hong Kong College of Family Physicians with the following:

- i) Photocopy of the current Annual Practising Certificate;
- ii) A recent photo of the applicant (passport size);
- iii) A signed "Disclaimer of Liability";
- iv) An administration fee for application of HK\$1,000 by crossed cheque payable to "HKCFP Holdings and Development Limited". This fee is non-refundable;
- v) A Course Fee of HK\$38,000 (or HK\$76,000 for non-members) by crossed cheque payable to "HKCFP Holdings Development Limited". This fee is non-transferable and non-refundable.

Every successful applicant will be notified by an official letter of admission.

The Research Committee of the Hong Kong College of Family Physicians is calling for The Award for The Best Research of the Year 2019. All members and fellows of the College are invited to participate and submit their research papers to the Research Committee for selection. The Award will be presented at the Conferment Ceremony in 2020.

## Entry and assessment criteria are listed below:

## **Entry Criteria:**

- 1. The principal investigator has to be a Member or a Fellow of the Hong Kong College of Family Physicians.
- 2. The research must be original work of the investigator(s).
- 3. The research should be conducted in Hong Kong.
- 4. The research must have been completed.
- 5. The paper should be presented under the standard headings of Abstract, Introduction, Methodology, Results, Discussion and Conclusion. References should be listed in full at the end in Vancouver format.

## **Assessment Criteria:**

- 1. How relevant are the topic and findings to Family Medicine?
- 2. How original is the research?
- 3. How well is the research designed?
- 4. How well are the results analyzed and presented?
- 5. How appropriate are the discussion and conclusion(s) drawn?
- 6. How useful are the results for patient care in the discipline of Family Medicine?
- 7. How much effort is required to complete the research study?

Each research project submitted will be assessed according to the seven criteria listed above by a selection panel. Each criterion may attract a different weighting to be decided by the selection panel. Please send your submission either:

## **HKCFP Research Fellowship 2020**

## Introduction

The HKCFP Research Fellowship was established by the Hong Kong College of Family Physicians to promote research in Family Medicine. The Grant is up to the value of HK\$ 100,000. Applicants are expected to have regular contact with a nominated supervisor with Master or equivalent degree or above.

## Eligibility

Applicants for the HKCFP Research Fellowship must be active Fellow, Full member or Associate Member of the HKCFP. New and emerging researchers are particularly encouraged to apply. However, full-time academic staff of Universities would not be eligible to apply.

## Selection criteria

Application will be judged on\*:

- Training potential of applicants
- Relevance to family medicine and community health
- Quality
- Value for money
- Completeness (incomplete or late applications will not be assessed further)

\* Please note that new researchers and those at an early stage of their research careers are defined as those who have not led a major research project or have fewer than 5 years of research experience.

## Masks - what should we know now?

It is by no doubt that face MASK is currently one of the most hot topics in Hong Kong, as we are working hard to fight against COVID-19 outbreak. The long discussion of who and when and where to use face mask will keep on until the exact route of transmission is officially documented and finalised. As a family physician, we should be more equipped in the knowledge of face masks, as it would be definitely a common enquiry by our patients.

## A. Types of face masks

## - Surgical mask

Loose-fitting, disposable device that creates a physical barrier between the mouth and nose of the wearer and potential contaminants in the immediate environment.

If worn properly, a surgical mask helps to block large particle droplets, splashes, sprays that may contain germs, but it does not provide complete protection from germs and other contaminants because of the loose fit between the surface of the mask and your face.

Most surgical masks adopt a three-layer design which are outer fluid resistant layer, middle filter layer and inner moisture-absorbing layer. Mask without the above functions is not recommended as it cannot provide adequate protection against infectious diseases transmitted by respiratory droplets.

### - Respirator

A respirator is a respiratory protective device designed to achieve a very close facial fit and very efficient filtration of airborne particles.

If properly fitted, the filtration capabilities of respirators exceed those of face masks. However even a properly fitted respirator does not completely eliminate the risk of viral/bacterial transmission.

Most N95 respirators are manufactured for use in construction and other industrial jobs that expose workers to dust and small particles. However some respirators are intended for use in healthcare setting. These N95 respirators are class II devices regulated by the FDA, under CFR 878.4040, and CDC NIOSH.

Before initial use of N95 respirator, fit test should be performed to select a suitable type, model and size of respirator for individual respirator user.

## B. Surgical Masks

### 5. South Korea KF (Korea filter) Requirements for Medical Face Masks

KF80-rated masks block on average 80% percent of PM of 0.6µm in diameter.

KF94-rated masks block on average 94% percent of PM of  $0.4\mu m$  in diameter.

KF99-rated masks block on average 99% percent of PM of  $0.4\mu m$  in diameter.

### Procedure of putting on surgical mask

- Perform hand hygiene
- Put the coloured side as outer side of the mask, with the metallic strip uppermost
- For ear-loop type surgical mask, position the elastic bands around both ears
- Extend the surgical mask to fully cover mouth, nose, and chin
- Mould the metallic strip over nose bridge and the surgical mask should fit snugly over the face
- Perform hand hygiene

## C. Respirators

There are different classifications of respirators worldwide:

### Classification of respirators - NIOSH classification

- NIOSH: National Institute for Occupational Safety and Health
- Respirators that filter out at least 95% of airborne particles during "worst case" testing using a "most-penetrating' sized particle are given a 95 rating. Those that filter out at least 99% receive a "99" rating. And those that filter at least 99.97% receive a "100" rating.
- Respirators in this group are rated as N, R, or P for protection against oils. This rating is important in industry because some industrial oils can degrade the filter performance so it doesn't filter properly
- N: Non resistant to oil
- R: somewhat resistant to oil
- P: strongly resistant to oil

### Procedure on putting on N95 respirator

- Select your own correct model and size of N95
- Check that the respirator is clean and in good condition before each use. Inspect for:
- Condition of the parts (e.g., facepiece, harness, valves, filters, cartridges, etc.) for cracks, tears, holes, distortion or warping.
- Tightness of the connections
- End-of-service life indicator (if present) or shelf-life date
- Perform hand hygiene
- Put the respirator on your face tightly covering your nose and mouth
- put the upper strap up and over back of your head, put the lower strap up and over back of your neck
- Using your fingertips to mould the metallic strip over the nose bridge, and the respirator should fit snugly over the face
- Perform seal test (see below)
- Perform hand hygiene

### Fit test for respirator

- There are Qualitative Fit Test (QLFT) and Quantitative Fit Test (QNFT)
- Retest is needed under the following circumstances: A significant change on facial contour affecting the respirator fit
- A significant increase or decrease in weight (+/- 10%)
- Change in facial structure or scarring due to dental work, cosmetic surgery or accidents
- When no supply of appropriate model or size of respirator
- Any other condition that may interfere with facepiece sealing

### Seal check for respirator

### - Positive seal check

Place both hands completely over the respirator and exhale sharply. If air leaks around respirator edges, adjust the straps back along the sides of your head. Perform seal check again if an adjustment is made

### Negative seal check

Place both hands completely over the respirator. Inhale sharply and the respirator will collapse slightly. If inward leakage of air is detected, the seal of the respirator its considered unsatisfactory. Reposition it by adjusting the straps. If you cannot achieve a proper seal, do not enter the contaminated area

### D. Should we re-use face masks?

In general we do not recommend patients to re-use face masks (except the reusable part in P100 series).

# Maintenance of Household Hygiene – What is the latest evidence, and how may we advise our patients?

In view of the concurrent severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) / coronavirus disease 2019 (COVID-19) pandemic and the knowledge of the disease being spreadable through droplets and contact transmissions, members of the public have generally been more aware on the maintenance of personal / environmental hygiene to avoid the spread of the disease, as evidenced by the popular observations of cleaning agents being out of stocks in shops and supermarkets around us. As family physicians, how may we advise our patients about home hygiene in view of the ongoing pandemic? I have tried to look up on evidence & advice around the world and made up a summary as below:

A recent review article published on 6<sup>th</sup> February, 2020 from Journal of Hospital Infection<sup>1</sup> shows that human coronaviruses such as Severe Acute Respiratory Syndrome coronavirus (SARS-CoV), Middle East Respiratory Syndrome coronavirus (MERS-CoV) or endemic human coronaviruses (HCoV) can persist and inanimate surfaces like metal, glass or plastic for up to 9 days, but can be efficiently inactivated by surface disinfection procedures with **62-71% ethanol**, **0.5% hydrogen peroxide or 0.1% sodium hypochlorite within 1 minute**. Despite the lack of further data available to discuss the SARS-CoV-2 virus in particular, the information still helps us to appreciate and have an idea on how it may behave in the environment around us. The above paper had also discussed other biocidal agents that can inactivate various coronaviruses, for example glutardialdehyde (0.5-2.5%), formaldehyde (0.7-1%) and povidone iodine (0.23-7.5%), but they may not appear to be the appropriate household chemicals due to chemical safety issues associated.

## Advice on Household Cleansing from Various Health Authorities

## 1) Commercial options available

With reference to the currently available literature, The National Environmental Agency of Singapore had launched an interim list of household products and active ingredients for disinfection of COVID-19<sup>2</sup> to the public. As extracted from the guideline, it had suggested under the stated working concentrations, sodium hypochlorite (0.05-0.5%), 70% ethyl alcohol, accelerated hydrogen peroxide (0.5%) and various other active chemical ingredients would be effective against coronaviruses, whilst the page had also suggested some currently available commercial products in the market that the public can choose for daily use. Whereas for those who are interested to read up about similar local scientific analysis and **suggestions** 

on commercially available brands of bleach solutions in the local market in Hong Kong, the Choice Magazine (選擇月刊)<sup>3</sup>, published by The Consumer Council of Hong Kong had also run some similar tests. You may read up about them from their official links below:

## 2) Suggestion on Cleaning

For general household "preventive" cleaning, the World Health Organization (WHO)<sup>4</sup> had suggested "to ensure that environmental cleaning and disinfection procedures are followed consistently and correctly. Thoroughly cleaning environmental surfaces with water and detergent and applying commonly used hospital-

Email: alkyyu@hkcfp.org.hk' level disinfectants (such as sodium hypochlorite) are effective and sufficient procedures". Whilst the Department of Health <sup>5</sup> would usually suggest the public the use of 1:99 diluted household bleach solution (mixing 1 part of 5.25% bleach with 99 parts of water) for general household cleaning and disinfection.

Whilst for environmental cleaning and disinfection of premises with prior exposure to confirmed cases of the COVID-19, I have found the following links being useful:

Some useful points as extracted from the Singapore Guideline<sup>6</sup> which I think is also useful and practical when our patients ask for cleaning advice:

## Items to Prepare for Cleaning of Premises:

Prepare these items before you start to clean the premises:

- 1. Disposable gloves
- 2. An appropriate disinfectant with indication of effectiveness against coronavirus, or bleach solution.
- 3. A change of clothes
- 4. Plastic/Trash bags
- 5. Water
- 6. Disposable cloths or rags
- 7. Pail
- 8. Mop



## Cleaning Instructions:

- Before you start cleaning, put on a pair of gloves. Avoid touching your face, mouth, nose and eyes during clean-up. There is no need to wear a mask if you are well.
- 2. Prepare the disinfectant or bleach solution (mixing 1 part of 5.25% bleach with 49 parts of water).
- 3. Keep the windows open for ventilation.
- 4. Mop the floor with the prepared disinfectant or bleach solution, starting from one end of the premises to another.
- 5. Soak cloths with the prepared disinfectant or bleach solution and use them to wipe all frequently touched areas (also referred to as the "high-touch surfaces" from the CDC guidelines, e.g. lift buttons, handles, doorknobs, armrests, seatbacks, tables, air/light controls, keyboards, switches, blinds, windows, walls, etc.).
- 6. Avoid using a spray pack to apply disinfectant on potentially highly contaminated areas (such as toilet bowl or surrounding surfaces) as it may create splashes which can further spread the virus.
- 7. Clean toilets with a separate set of cleaning equipment (disposable cleaning cloths, mops, etc.) using disinfectant or bleach solution.
  - A. Clean all accessible surfaces (sinks, taps, soap dispensers, toilet roll dispensers, walls, cubicle doors, cubicle locks, handles, flush buttons, etc.).
  - B. Clean urinals and toilet bowls with a brush and use a separate cloth for seat covers. Brush and cloths used for these should not be used for other surfaces.
  - C. After disinfection, clean the floor with disinfectant from the exit inwards.
- 8. Remove cushion covers and other fabrics for washing. Use a washing machine and detergent to wash.
- Repeat cleaning the floor with the prepared disinfectant or bleach solution, starting from one end of the premises to another. Avoid going from an area that has not been cleaned to an area that has been cleaned, to avoid dirtying the cleaned area.
- Throw away all cloths and rags used, as well as other waste from the clean-up, into double-lined plastic/ trash bags.
- 11. Remove gloves, wash your hands with soap and water.
- 12. Throw gloves into double-lined plastic/trash bags.
- 13. All waste generated from the clean-up (gloves, cloths, etc.) should be segregated from other waste (e.g. food waste), and disposed of as regular waste as soon as possible.
- 14. Shower or wash up and change your clothes immediately after the clean-up.
- 15. Air and ventilate the premises.

There are also some additional key advices as extracted from the CDC guideline for close contacts:

- Make sure that shared spaces in the home have good air flow
- Wear a disposable facemask and gloves when you touch or have contact with the patient's blood, stool, or body fluids, such as saliva, sputum, nasal mucus, vomit, urine.
  - Immediately remove and wash clothes or bedding that have blood, stool, or body fluids on them.
  - While handling soiled items, keep soiled items away from your body. Clean your hands (with soap and water or an alcohol-based hand sanitizer) immediately after removing your gloves.
- Avoid sharing household items with the patient, such as dishes, drinking glasses, cups, eating utensils, towels, bedding, or other items. After the patient uses these items, they should be washed thoroughly.

# Other advice that you should also consider discussing with your patients

There are also some additional key advices as extracted from the CDC guideline for close contacts:

- Recent local studies<sup>7</sup> had suggested that unlidded toilet flushing may lead to generation of bioaerosols, leading to potential spread of pathogens through droplets, suggesting the importance for toilet flushing with lid coverage
- Advice on regularly filling up of "U-Traps" at homes to prevent spread of diseases and regular maintenance of pipes at home to prevent spread of pathogens from faulty pipelines. Please also visit the following poster link from Centre for Health Protection for further details:

## **ELIGIBILITY AND AUTHOR GUIDELINES**

To be eligible for participation in the Full Research Paper Competition, **the first author of the paper must meet ALL of the following conditions**:

- (1) The author must be a member of the HKCFP and register at the Conference;
- (2) The author completes the majority of the research and writing for the paper;
- (3) The author has not used the paper to apply for other awards.

The participating paper should be a full-length article. It should include a structured abstract of no more than 250 words. The text should contain 2,000 - 3,000 words, organized as **INTRODUCTION, METHODOLOGY, RESULTS and DISCUSSION**. It should consist of no more than 5 illustrations (tables/figures). Only electronic versions will be accepted. The full paper should be typed in 12 point size in Microsoft Word format.

For Best Trainee Research Paper Award, additional eligibility applies:

- (1) The first author must be a trainee of HKCFP or within 3 years of completion of vocational training;
