REGULATIONS

1. Detailed entry requirements:

- A The submission must not have previously been submitted to any competition and/or won an award or prize of any kind.
- B It must not include content which is derogatory, offensive, threatening, defamatory or contain any content that is inappropriate, indecent, sexual, profane, indecent, discriminatory in any way, or that promotes hatred or harm against any group or person, or otherwise does not comply with the theme and spirit of the Competition.
- C It must not contain content, material or any element that is unlawful, or otherwise in violation of or contrary to all applicable laws or regulations where the Photographs were created.
- D It must not contain any content, material or element that displays any third party advertising, slogan, logo, trademark or otherwise indicates a sponsorship or endorsement by a third party, commercial entity or that is not within the spirit of the Competition.
- E It must not reference any person, group, or organisation without their written permission.
- F It cannot contain any content, element, or material that violates a third party's intellectual property rights, including but not limited to copyrights, trademarks, patents, trade secrets, logos, contract and licensing rights, rights of publicity or privacy, moral rights, or any other intellectual property rights.
- G It must not be subject to any third party agreement(s) which may require the Hong Kong College of Family Physicians to pay any sum of money to any person or entity as a result of its use or exploitation of the Photographs or rights therein.

2. Detailed photographic requirements:

- A The photographs need not be taken with a digital camera; scans of negatives, transparencies, or photographic prints are acceptable.
- B Entries must be submitted by electronic format to <u>hkcfpphotocontest@gmail.com</u>. The image size should be larger than 8 million pixels, in RGB colour mode and in JPEG format. Both colour or black & white photos are accepted. The file size must not exceed 10 MB. Photographs must not be extensively computer retouched. Collage, HDR, stitched panoramas, polyptychs, etc. are not allowed.
- C The content of a picture must not be altered by adding, rearranging, reversing, distorting or removing people and/or objects from within the frame. There are two exceptions:

I. Cropping that removes extraneous details is permitted;

- II. Removing sensor dust or scratches on scans of negatives is permitted.
- D Adjustments of colour or conversion to grayscale that do not alter content are permitted, with two exceptions:
 - I. Changes in colour may not result in significant changes in hue, to such an extent that the processed colours diverge from the original colours.
 - II. Changes in density, contrast, colour and/or saturation levels that alter content by obscuring or eliminating backgrounds, and/or objects or people in the background of the picture, are not permitted.

3. Privacy

Participants agree that personal data entered during the registration, including name, mailing address, phone number, and email address may be processed, stored, shared and otherwise used for the purposes and within the context of the Competition.

4. Publicity

By accepting a prize, entrant agrees to HKCFP's use of his or her name and/or likeness and Photographs for advertising and promotional purposes without additional compensation.

5. Authorisation of copyrights

Entrants retain copyrights of their work. For awarded pictures, copyright holders grant the HKCFP unlimited royalty-free non-exclusive use of high-resolution pictures for all related publications and activities.

6. Submission
