Message from the President

As the number of Omicron cases is rising rapidly, tighter measures are being implemented across the world to prevent the spread of the latest variant of concern of the COVID-19 virus. And vaccination against COVID-19 is still the best way to provide protection for the individual and the community as a whole. So, once again, for people who are not up to date with the COVID-19 vaccinations, especially those in the elderly age group and those with chronic illnesses, please go and see your family doctor and receive the vaccinations at the earliest available opportunities.

During a recent meeting of the local expert panels, the initial studies on the effectiveness of COVID-19 vaccines against Omicron variant, overseas recommendations on use of COVID-19 vaccines as well as the latest situation of Omicron variant were reviewed. It has been concluded that people aged 18 years and above who had received two doses of Comirnaty or CoronaVac vaccine, a third dose of Comirnaty vaccine is highly recommended to be administered as soon as possible six months after the second dose. And people who are to travel overseas can get this booster jab earlier but not less than three months after the previous dose. Pregnant and lactating women are also recommended to have the mRNA vaccines, including a third dose, with the same administration arrangements as for the general population. A second dose of Comirnaty vaccine six months after the first dose is recommended for people who had previous infection. Regarding children and adolescents aged 12 to 17, the panels also updated that recent new data suggest that two doses of Comirnaty vaccine with a longer interval would result in better immune

response as well as lowering the risk of myocarditis and/or pericarditis when compared with a shorter interval. In view of the rapid spread of Omicron variant, people aged 12 to 17 years are recommended to receive the second dose of the Comirnaty vaccine 12 weeks after the first dose of Comirnaty vaccine. Hong Kong is also seeing imported cases of Omicron from various places and the Government has tightened up the pre-flight and quarantine requirements especially towards returnees from Group A specified places, e.g. negative COVID-19 PCR test within 48 hours of departure, first 4 of the 21 days quarantine at Penny's Bay Quarantine Centre, a series of COVID-19 testing.

In order to facilitate cross-border travelling from Hong Kong to Guangdong or Macao, The Hong Kong Health Code System has been created recently to facilitate qualified people to register for an account with their identity documents, upload their visit records from the "Leave Home Safe" App, perform health declaration and send their recognised nucleic acid test result and vaccination records to the Guangdong Health Code (Yue Kang Code) System or the Macao Health Code System as appropriate, in compliance with the requirements for inbound traveler health declaration

and exemption from compulsory quarantine at Guangdong or Macao. (<https://www.info.gov.hk/gia/general/202112/09/P2021120900238.htm>) Three kinds of codes, namely the Red, Amber or Green Hong Kong Health Code are generated by The Hong Kong Health Code system and the code generation standards are aligned with that of the "Yue Kang Code" issued by Guangdong Province. The Red code is generated for people who have been confirmed to have COVID-19 infection, are probable cases, close contacts, household contacts of close contacts, have recovered from COVID-19 but were within 14 days of discharge from hospital, are currently under compulsory quarantine, and persons who have shown symptoms in the past 14 days; people who have visited or resided in high-risk areas in the preceding 21 days, or arrived at Hong Kong in less than 21 days, including people who have completed compulsory quarantine or are exempted from the

compulsory quarantine requirement when they enter Hong Kong (except for those who entered Hong Kong from the Mainland or Macao under the "Return2hk" or "Come2hk" Schemes) will be given the Amber code; and the Green code will be issued to all the other people. And the Hong Kong Health Codes will be valid up to 11:59 pm on the day of application.

THIRTY-SIXTH CONJOINT HKCFP/RACGP FELLOWSHIP EXAMINATION FIRST ANNOUNCEMENT

The Board of Conjoint Examination is pleased to announce the following information on the Thirty-sixth Conjoint Fellowship Examination with the Royal Australian College of General Practitioners to be held in 2022.

(1) REQUIREMENTS AND ELIGIBILITY

All candidates **MUST** be FULL OR ASSOCIATE members of BOTH HKCFP AND RACGP* at the time of application for the Examination and at the time of the Conjoint Examination.

(*Documentary evidence is required with the application – including a valid RACGP number.)

[Note : All candidates are required to have renewed their RACGP membership for the year 2022/2023 on or before 31 July 2022. Failure to comply with the above may result in denial of admission to the Examination.)

In addition, they must be EITHER CATEGORY I OR CATEGORY II CANDIDATES: -

- (a) **CATEGORY I CANDIDATES** are graduate doctors (FULLY OR LIMITED registered with the Hong Kong Medical Council) who are undergoing or have completed a fully approved vocational training programme as outlined in the College's Handbook for Vocational Training in Family Medicine.

After satisfactory completion of two years of approved training, Category I candidates or trainees may apply to sit the Written Examination, both the two segments of which must be taken at the same attempt. After satisfactory completion of four years of supervised training, Category I candidates may apply to sit the Clinical Examination.

[Note: All Category I candidates who are current vocational trainees and apply to sit the Written Examination **MUST** submit evidence of completion of at least 15 months of approved training by 31 March 2022, together with the application. Those current vocational trainees who apply for the Clinical Examination **MUST** submit evidence of completion of at least 39 months of approved training by 31 March 2022, together with the application. Candidates who have already completed vocational training **MUST** submit evidence of completion of vocational training, together with the application.

Part-time trainees must submit evidence of completion of their vocational training by the time of the Written Examination before they can apply to sit the examination.)

- (b) **CATEGORY II CANDIDATES** are doctors who are FULLY registered with the Hong Kong Medical Council and have been predominantly in general practice in Hong Kong for not less than **five** years by 30 June 2022, provided that the experiences should be within the most recent 10 years.

Category II candidates may opt to only sit for the Written Examination at the first and subsequent application.

(Please Note:

For successful Category I candidates who had enrolled in the vocational training program before 31 December 2018, and who will apply for the award of RACGP Fellowship before 1 March 2027, they are eligible for the award of the Fellow of the RACGP (FRACGP). All other candidates are eligible to apply for the award of International Conjoint Fellow of the RACGP (ICFRACGP).

*For successful Category II candidates who sit the Conjoint examination for the first time on or before 2022 and pass it no later than 2026, they are eligible to apply for the award of RACGP Fellowship before 1 March 2027. **However, the award of FRACGP or ICFRACGP will be subject to the decision of RACGP.***

Enquiries about eligibility to sit the examination should be directed to the Chairman of the Board of Conjoint Examination.

The eligibility of candidates of both Categories I and II is subject to the final approval of the Board of Conjoint Examination, HKCFP.

Application will not be processed unless all the required documents are submitted with the application form with the appropriate fees.

(2) FORMAT AND CONTENTS

- A. Written Examination
Applied Knowledge Test (AKT)*, and
Key Feature Problems (KFP)

**Note: Multiple Choice Questions (MCQ) has been renamed as Applied Knowledge Test (AKT) from Conjoint Exam 2018, with no major change on the exam format.*

- B. Clinical Examination
Objective Structured Clinical Examination (OSCE)

(3) PRE-REQUISITE FOR CLINICAL SEGMENTS

All candidates applying to sit for the Clinical Examination of the Conjoint Fellowship Examination MUST possess a Advanced Primary Care Life Support (APCLS) certificate issued by the HKCFP*. The validity of this certificate must cover the time of the Clinical Examination.

Application will not be processed unless the pre-requisite is fulfilled.

*Note: In regarding the APCLS certificate issued by the HKCFP, the dates of APCLS workshops & examinations for 2022 will be confirmed in due course. Please register with our College secretariat at 2871 8899 IMMEDIATELY if you do not hold a valid APCLS certificate issued by HKCFP and intend to sit for the Conjoint Examination 2022.

(4) CRITERIA FOR A PASS IN THE EXAMINATION

A candidate will be required to pass the entire Written Examination in one sitting. That is, if one fails the Written Examination, both the AKT and KFP segments have to be re-taken. Successful Written Examination result can be retained for three years (until the Clinical Examination of 2025).

The Clinical Examination can only be taken after successful attempt of the Written Examination. If one fails the Clinical Examination, all the OSCE stations have to be re-taken.

A candidate has to pass both the Written and the Clinical Examinations in order to pass the Conjoint HKCFP/RACGP Fellowship Examination.

(5) APPLICATION AND EXAMINATION FEES

Application forms are available from the College Secretariat at Room 803-4, HKAM Jockey Club Building, 99 Wong Chuk Hang Road, Aberdeen, Hong Kong. You may also download the application forms from our College website, <http://www.hkcfp.org.hk>. Please note that the deadline for application is **7 April 2022 (Thursday)**.

(6) REFUND POLICY

If a candidate wishes to withdraw from the examination, and written notice of withdrawal is received by the College 60 days or more prior to the date of the examination, he will receive a refund of \$33,000 (for the whole examination), \$16,500 (for the written examination) or \$16,500 (for the clinical examination). The application fee of \$3,000 will not be refunded.

No refund will be given if the written notice of withdrawal is received by the College within 60 days of the date of the examination.

All fees paid are not transferable to subsequent examinations.

Hong Kong Primary Care Conference 2022

On behalf of the Hong Kong College of Family Physicians, the members of the Organizing Committee and myself, we are very proud to announce the “13th Hong Kong Primary Care Conference” under the overarching theme of: “Committed. Versatile. Ever-growing: Primary Health Care in the Time of COVID” which will be held online from 17th to 19th of June 2022.

This year's conference takes its theme from the COVID-19 pandemic that, for almost two years now, has shocked the world and will continue to affect how we conduct our daily lives. - (2) Relevance and impact to primary care (e.g. importance of the topic and the impact of the findings on the practice or development of primary care).

The panel reserves the right not to grant an award for the year.

As cycle year 2021 is going to be finalized, please kindly check your updated report by visiting the College website at <http://www.hkcfp.org.hk/>

The committee wishes to highlight that Colleagues **must engage in ALL categories of activities** in order to fulfill the QA Certificate 2020-2022 criteria, briefly summarized as follows:

- (1) A minimum of 90 points in total, including **at least 30 CPD points**
- (2) A maximum of 45 credit points will be counted for each category of educational activities
- (3) Participants must engage in **ALL** categories of activities
- (4) Maximum point set for Subcategories (3.01, 3.02, 3.03a-c, 3.04, 3.09, 3.10)

For Point (2) and (3) above, the 'categories' are referring to

- i) Category 3, related to CPD activities,
- ii) Category 4, related to activities organized by our College alone, and
- iii) Category 5, related to pre-accredited activities organized by other professional institutions themselves or in collaboration with our College. Examples of this category include accredited educational events organized by the Hong Kong Medical Association, The Universities, the Hospital Authority, and the Primary Care Office / Department of Health.

Stanley Public Dispensary – A Vivid Canvas of History

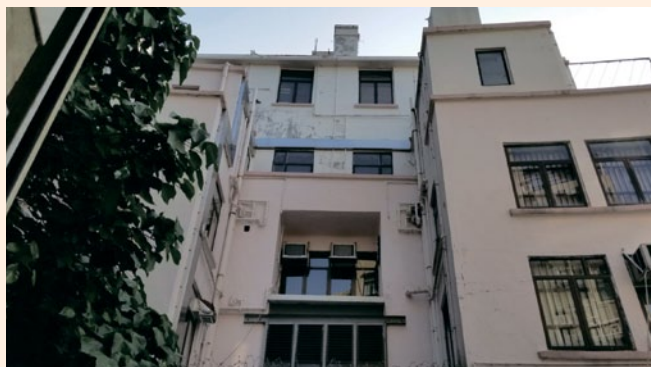

What is the first thing that comes to your mind when you think of Stanley? The bustling streets? Murray House? Little do people know that a place of significant historical value exists in Stanley. Let's shine the spotlight on it.

Stanley Public Dispensary, located at Wong Ma Kok Road of Stanley, is a three-storey building built as a residence house in the 1930s. After the Second World War, the Government purchased the building and refurbished it as a public dispensary and maternity home of the former Medical and Health Department to serve the population nearby. Many people born in the 60s and 70s took their first breath there. This is a place where nostalgia runs rampant and many people fostered a sense of belonging.

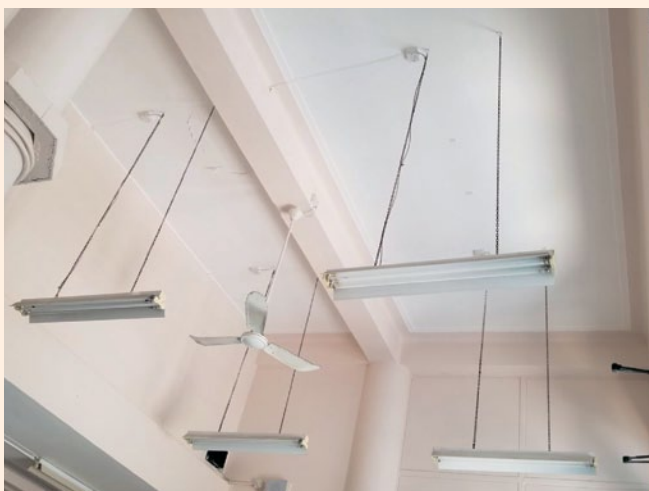


Rear view of Stanley Public Dispensary

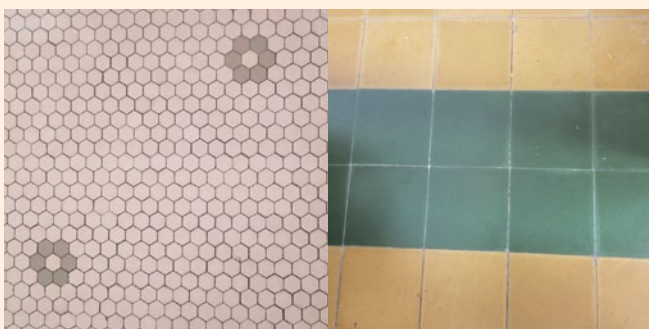
Nowadays, it is a general out-patient clinic managed by the Hospital Authority and the Stanley Sub-office of the Social Welfare Department. The building has been accorded with Grade 3 historic building status and there is definitely a good reason behind. The building displays Art Deco features in the form of stepped recessions in the wall on the front and rear elevations. Also, there are stylised frieze moulding on the front elevation, tubular steel railings, regularly spaced windows and pole on top of the

outer wall of the verandah. The plan is a U-shaped and symmetrical with a small courtyard at the rear.

Internally, original features such as staircase balustrading, cornices, doors and floor tiles still exist. There is high ceiling with high hanging lights and ceiling fans. A vintage Stafford safe can be found in the shroff although it is not used any more. As the building has been used as a maternity home, there are still patients who told us that he/she was born in this building during their medical consultations.

Furthermore, some historical records of Midwife's Case Register, Return of District Midwifery and Monthly Report of Ante-Natal Clinic of the Stanley Maternity Home dated back to the 1960s can be found. Medical antiques such as Esbach's albuminometer and Woolwich breast shield still remains in the building. Esbach's albuminometer was used in old times to determine the presence and amount of albumin in a urine sample. It consists of a graduated tube and a wooden stand with cover. Other historical items such as Kerosene pressure lantern are still present.

From these features, it is clear that the Stanley Public Dispensary is so much more than just a regular clinic. It is a monument of history and the home of collective memories. We shall recognize the importance of heritage preservation and learn how to treasure our cultural heritage.

Oral Antiviral For COVID-19: A Game Changer?

Up until recently, authorised antiviral treatment for COVID-19 had to be given intravenously or by injection. The U.S. Food and Drug Administration (FDA) issued an emergency use authorization for Pfizer's Paxlovid (nirmatrelvir [PF-07321332] tablets and ritonavir tablets) and Merck's antiviral pill, Molnupiravir, for the treatment of mild-to-moderate COVID-19 in patients with positive results of direct SARS-CoV-2 viral testing, and who are at high risk for progression to severe COVID-19, including hospitalization or death shortly before Christmas 2021.¹

The whole world is excited about the development of oral antiviral treatment against COVID-19 which can be administered at home. Many believe and hope that this will be a game-changer to the pandemic. Apart from UK, many countries, including US have already placed orders for these drugs.

Paxlovid

Paxlovid which includes nirmatrelvir, a novel main protease (M^{pro}) inhibitor originating in Pfizer's laboratories, was specifically designed to block the activity of the SARS-CoV-2 M^{pro}, an enzyme that the coronavirus needs to replicate. Co-administration with a low dose of ritonavir helps slow the metabolism, or breakdown, of nirmatrelvir in order for it to remain active in the body for longer periods of time at higher concentrations to help combat the virus.

Nirmatrelvir is designed to inhibit viral replication at the proteolysis stage. In preclinical studies, nirmatrelvir did not demonstrate evidence of mutagenic DNA interactions.²

The FDA based its decision on clinical data from the Phase 2/3 EPIC-HR (Evaluation of Protease Inhibition for COVID-19 in High-Risk Patients), a randomized, double-blind, placebo-controlled clinical trial, which enrolled non-hospitalized adults aged 18 and older with confirmed COVID-19 who are at increased risk of progressing to severe illness or were 60 years and older regardless of prespecified chronic medical conditions. All patients had not received a COVID-19 vaccine and had not been previously infected with COVID-19. The data demonstrated an 89% reduction in the risk of COVID-19-related hospitalization or death from any cause in adults treated with PAXLOVID, compared to placebo, within three days of symptom onset (primary endpoint). No deaths occurred in the treatment group compared to nine deaths in the placebo group by Day 28. Similar results were seen in those treated within five days of symptom onset (secondary endpoint), with an 88% reduction in risk and no deaths observed in the treatment group. Treatment-emergent adverse events were comparable between PAXLOVID (23%) and placebo (24%), most of which were mild in intensity.¹

While PAXLOVID clinical trials did not include patients under the age of 18, the authorized adult dosing regimen is expected to result in comparable blood concentration levels of PAXLOVID in pediatric patients 12 years of age and older weighing at least 40 kg. Additional Phase 2/3 clinical trials are ongoing in adults at standard risk (i.e., low risk of hospitalization or death) of progressing to severe illness, and in those who have been exposed to the virus through household contacts.¹

Current variants of concern can be resistant to treatments that inhibit the spike protein found on the surface of the SARS-CoV-2 virus, due to its high mutation rate. PAXLOVID, however, works intracellularly by binding to the protease of the SARS-CoV-2 virus to inhibit viral replication. Nirmatrelvir has shown consistent in vitro antiviral activity against current variants of concern (i.e., alpha, beta, delta, gamma, lambda, and mu). In addition, nirmatrelvir potentially inhibited the M^{pro} associated with Omicron in an in vitro biochemical assay.²

PAXLOVID is authorized to be administered at a dose of 300 mg (two 150 mg tablets) of nirmatrelvir with one 100 mg tablet of ritonavir, given twice-daily for five days. It is not authorized for pre/post exposure prevention of COVID-19 or for initiation of treatment in those requiring hospitalization due to severe or critical COVID-19.

Molnupiravir

MSD and Ridgeback Therapeutics announced, to the World on 1st October 2021, that their investigational antiviral, molnupiravir, could reduce the risk of hospitalization and death by about 50% in patients with mild to moderate COVID-19.³ Shortly afterwards on 4th November, the United Kingdom Medicines and Healthcare products Regulatory Agency (MHRA) granted authorization in the United Kingdom for molnupiravir (with tradename, Lagevrio), to be used in the treatment of mild-to-moderate COVID-19 in adults with a positive SARS-CoV-2 diagnostic test and who have at least one risk factor for developing severe illness.⁴

Molnupiravir is a ribonucleoside analog that inhibits the replication of SARS CoV-2.

UK's authorization is based on the positive results from a planned analysis from the Phase 3 MOVE-OUT clinical trial which is a randomized, placebo-controlled, double-blind, multi-site study:

Non-hospitalized, Unvaccinated patients, who have at least 1 risk factor for poor disease outcomes (older age > 60, heart disease, diabetes, obesity) with confirmed mild to moderate COVID-19, recent onset symptoms within 5 days, were randomized to molnupiravir 800mg twice daily versus placebo. The primary end point is the percentage of participants who are hospitalized and/or

die from the time of randomization through Day 29. The trial was conducted in many countries, Brazil, Canada, Chile, Colombia, France, Germany, Guatemala, Mexico, Philippines, Russia, South Africa, Spain, Taiwan, Ukraine, the United Kingdom and the United States. Delta, Gamma and Mu variants accounted for nearly 80% of the baseline viral variants that had been sequenced at the time of the interim analysis. More than 300 patients were enrolled into each arm, on or before 5th, August, 2021.

The interim analysis showed that molnupiravir significantly reduced the risk of hospitalization or death from 14.1% (53/377) in the placebo group to 7.3% (28/385) in the molnupiravir group (absolute risk reduction 6.8%; 95% CI: 2.4, 11.3; $p=0.0012$), or a relative risk reduction of 48% (relative risk 0.52; 95% CI: 0.33, 0.80).⁵

Furthermore, the drug demonstrated consistent efficacy across viral variants Gamma, Delta, and Mu. The incidence of any adverse event was comparable in the treatment and placebo groups (35% and 40%, respectively). Similarly, the incidence of drug-related adverse events was also comparable (12% and 11%, respectively). Fewer subjects discontinued study therapy due to an adverse event in the molnupiravir group (1.3%) compared to the placebo group (3.4%).

Merck released another announcement in the end of November with molnupiravir reducing the risk of hospitalization or death from 9.7% in the placebo group (68/699) to 6.8% (48/709) in the molnupiravir group, equivalent to an absolute risk reduction of 3.0% (95% confidence interval [CI]: 0.1, 5.9; nominal p -value=0.0218) and a relative risk reduction of 30% (relative risk 0.70; 95% CI: 0.49, 0.99). Nine deaths were reported in the placebo group, and one in the molnupiravir group. The adverse event profile for molnupiravir remained consistent with the profile reported at the planned interim analysis.⁶

However, with this evolving results, an advisory panel of experts still voted by 13 to 10, in favour, to recommend that the US Food and Drug Administration should grant an emergency authorisation to Merck's molnupiravir, for the outpatient treatment of covid-19.⁷

Will the introduction of home based oral antiviral treatment for COVID-19 be a game changer and return our lives to normality? Time will only tell once figures roll in with real life use of the medications. Accessibility will be a key element. As in the initial battle over COVID-19 vaccinations, global distribution was largely dependent on political and economic considerations. In November 2021, Pfizer signed a license agreement with the United Nations-backed Medicines Patent Pool to allow nirmatrelvir to be manufactured and sold in 95 countries.⁸ However, this deal excludes several countries with major COVID-19 outbreaks including Brazil, China, Russia, Argentina and Thailand. Apart from international boundaries, socio-economic status will be a large barrier for equitable treatment access. With trial studies up to

now, it has been demonstrated oral antiviral for COVID-19 are time critical treatments with lower efficacy for patients starting on days 4/5 post symptom onset. Will timely treatment be accessible for patients with lower socioeconomic status?

Other considerations include the pediatric population as current trial studies and authorisation of usage excludes the pediatric population. There are also concerns about the efficacy against future mutant variants and the potential for emergent resistant viruses in treated patients. There is yet no detailed information on their adverse effect profile and safety profile.

Also will oral antiviral for COVID-19 prevent further transmission in real life data? How will it prove itself in prevention in contact cases?

Whilst we are still waiting for further data to answer these questions our best proven arsenal remains in primary prevention with universal COVID vaccination.

1. The principal investigator has to be a trainee of the Hong Kong College of Family Physicians, or within 3 years of completion of vocational training.
2. For higher trainees who are submitting their Exit Examination research project for this award, they must have submitted their project to the Specialty Board and have passed the research segment of the Exit Examination.
3. The research must be original work of the investigator(s).
4. The research should have been conducted in Hong Kong.
5. The research must have been completed.
6. The paper should be presented under the standard headings of Abstract, Introduction, Methodology, Results, Discussion and Conclusion. References should be listed in full at the end in Vancouver format.

Assessment Criteria:

1. How relevant are the topic and findings to Family Medicine?
2. How original is the research?
3. How well is the research designed?
4. How well are the results analyzed and presented?
5. How appropriate are the discussion and conclusion(s) drawn?
6. How useful are the results for patient care in the discipline of Family Medicine?
7. How much effort is required to complete the research study?

Each research project submitted will be assessed according to the seven criteria listed above by a selection panel. 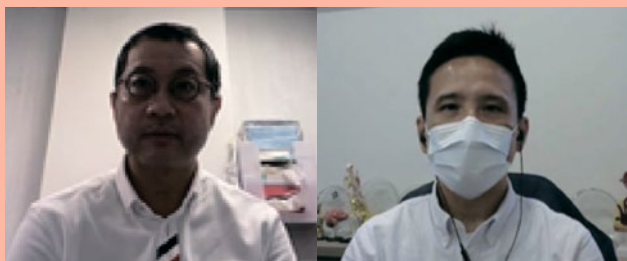

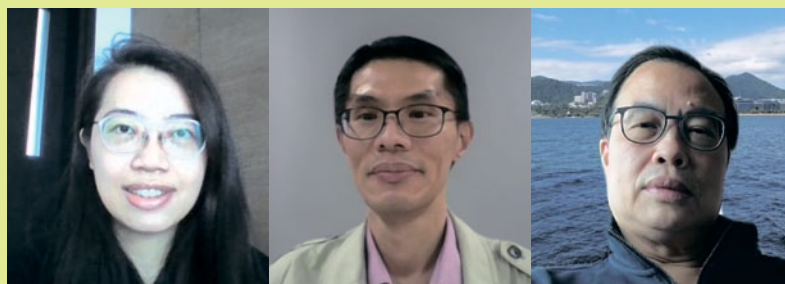

Advanced Primary Care Life Support (APCLS) Training and Examination Workshop 2022

As required by the Royal Australian College of General Practitioners (RACGP), an adequate CPR training course needs to have advance components on airway management, neck support and automated external defibrillation (AED) on top of basic life support. In order to align with our Sister College (RACGP) and to achieve reciprocal recognition in Conjoint Fellowship Examination and Quality Assurance Certificate, the CPR Subcommittee of the Board of Education is pleased to announce that an enhanced CPR course, the Advanced Primary Care Life Support (APCLS) has been launched since 2017.

APCLS course materials have been endorsed by HKCFP Council in 2015 and the Resuscitation Council of Hong Kong (RCHK) in 2016. The course aims to widen the scope of our existing CPR training course by adding several important elements: use of automated external defibrillator (AED), use of airways adjuncts and dealing with initial trauma care through use of neck support.

Tentatively, 2 APCLS Training and Examination Workshops will be held on 2022 **(27 February & 27 March 2022)**.

As no one is guaranteed to pass in the first attempt, members who plan to sit for the 2022 Conjoint Examination are strongly advised to register for our APCLS session. Members are reminded that a valid HKCFP APCLS Certificate is a pre-requisite for enrolment of the Conjoint Examination. Members who plan to sit for the 2022 Conjoint Examination are also reminded to check the validity of their HKCFP APCLS Certificate to make sure that it is valid at the time of application and also at the time Clinical Examination. HKCFP APCLS certificates are valid for 2 years.
