Message from the President

Earlier in the month, there were several cases of Legionnaire Disease (LD) reported by the Centre for Health Protection (CHP) of the Department of Health, including male and female patients aged between 62 to 92 years old living in various districts of the HKSAR. (https://www.info.gov.hk/gia/general/202403/11/ P2024031100426.htm?fontSize=1) The CHP mentioned that there are ongoing epidemiological investigations to identify potential sources of infection, high-risk exposure and clusters, if any. As of 9th March, a total of 13 LD cases had been reported this year. In 2023 and 2022, there were 121 and 80 cases respectively. People aged over 50, smokers, alcoholics and persons who are immunocompromised are more susceptible to LD. Situations that may increase the risk of infection include poor maintenance of water

systems; living in areas with old water systems, cooling towers or fountains; using electric water heaters, whirlpools and spas or hot water spring spas; and recent stays in hotels or vessels. Warm water [20 to

45 degrees Celsius) suits the growth of Legionellae. Aqueous environments such as water tanks, hot and cold water systems, cooling towers, whirlpools and spas, water fountains and home apparatus that support breathing can harbour the bacteria. People may become infected when breathing in contaminated aerosols and mist generated by artificial water systems, or when handling garden soil, compost and potting mixes. People who are immunocompromised should use sterile or boiled water for drinking, tooth brushing and mouth rinsing; avoid using humidifiers, or other mist- or aerosolgenerating devices; and if using humidifiers, or other mist- or aerosol-generating devices, fill the water tank with only sterile or cooled freshly boiled water, and not water directly from the tap. Also, clean and maintain humidifiers/devices regularly according to manufacturers' instructions. Never leave stagnant water in a humidifier/device. Empty the water tank, wipe all surfaces dry, and change the water daily.

The Hong Kong College of Family Physicians' (HKCFP's) Prize

In 1981, the College agreed to donate an annual sum for an indefinite period to establish a Prize, the "The Hong Kong College of **General Practitioners** Prizes", to be awarded to either an individual medical student or a group of medical students who has/have demonstrated special interest and skill in an approved investigation into aspects of general practice.

Following the transfer of the administrative responsibility of this prize to the Head of the General Practice Unit, Department of Medicine in 1990, the College agreed to award an additional prize for the best community-based research work.

The Prize was renamed the "The Hong Kong College of **Family Physicians** Prizes" in July 1997, following the change of the College's title.

The Department of Family Medicine and Primary Care of the University of Hong Kong will nominate the most distinguished student in the Specialty Clerkship in Family Medicine and Community Care each year. After consulting The Hong Kong College of Family Physicians, they will recommend the student for the Prize to the Faculty.

Dr. Gu Kwan Yin, the awardee of the HKCFP's Prize (2022-23), has written a thank-you letter to Our College.

Dear Donor,

I am fortunately awarded The Hong Kong College of Family Physicians' Prize (Family Medicine) 2022-23. Thank you for your generous donation to the LKS Faculty of Medicine, HKU for the establishment of the prize.


To me, this prize means recognition of my pursuit of academic excellence. Furthermore, it reminded me of the importance of Family Medicine and Primary Care. Elements of Family Medicine can be seen not only in its own specialty, but also in Medicine, Surgery, and beyond. Previously I was an intern at the Urology team at TWH Surgery, where many elective urology surgeries were done. Urinalysis was part of the routine admission orders for such patients, and occasionally it would show glycosuria. My seniors were kind enough to remind me to refer such patients to primary care for long term follow up for their likely newly diagnosed diabetes mellitus. This is just an example of how the principle of holistic care can be applied in other specialties.

Family Medicine has a close relationship with almost every specialty, cooperating to provide the best care to patients. I later interned at QMH Surgery. Quite a percentage of patients in the Specialist Out-Patient Clinics there could in fact be handed over to primary care for follow-up, for example small static asymptomatic hepatic cysts or hemangiomas. However, due to the lack of public education and awareness, it is often difficult to explain to patients why it would be appropriate to close their cases at SOPCs, as they often feel being followed-up by family physicians is a "downgrade" of care. Being awarded this prize reminded me once again the importance of public education on primary care.

Again please let me express my sincerest gratitude for your generous donation.

THIRTY-EIGHTH CONJOINT HKCFP/RACGP FELLOWSHIP EXAMINATION FINAL ANNOUNCEMENT

The Board of Conjoint Examination is pleased to announce the following information on the Thirty-eighth Conjoint Fellowship Examination with the Royal Australian College of General Practitioners to be held in 2024.

(1) REQUIREMENTS AND ELIGIBILITY

CATEGORIES OF CANDIDATES:

(a) CATEGORY I CANDIDATES <u>MUST</u> be FULL OR ASSOCIATE members of BOTH HKCFP AND RACGP* at the time of application for the Examination and at the time of the Conjoint Examination. (*Documentary evidence is required with the application – including a valid RACGP number. All candidates are required to have renewed their RACGP membership for the year 2024/2025 on or before 31 July 2024. Failure to comply with the above may result in denial of admission to the Examination.)

CATEGORY I CANDIDATES are graduate doctors (FULLY OR LIMITED registered with the Hong Kong Medical Council) who are undergoing or have completed a fully approved vocational training programme as outlined in the HKCFP College Handbook for Vocational Training in Family Medicine.

After satisfactory completion of two years of approved training, Category I candidates or trainees may apply to sit the Written Examination. The two segments can be taken separately in any order, or at the same attempt. After satisfactory completion of four years of supervised training, Category I candidates may apply to sit the Clinical Examination.

[Note: All Category I candidates who are current vocational trainees and apply to sit the Written Examination MUST submit evidence of completion of at least 15 months of approved training by 31 March 2024, together with the application. Those current vocational trainees who apply for the Clinical Examination MUST submit evidence of completion of at least 39 months of approved training by 31 March 2024, together with the application. Candidates who have already completed vocational training MUST submit evidence of completion of vocational training, together with the application.

Part-time trainees <u>MUST</u> submit evidence of completion of their vocational training by the time of the Written Examination before they can apply to sit the examination.)

Please Note:

For Category I candidates who have enrolled in the vocational training program before 31 December 2018, they will remain entitled to be awarded FRACGP, provided all requirements for Fellowship are met. All other candidates are eligible to apply for the award of International Conjoint RACGP Fellowship (ICFRACGP).

All successful candidates applying for the award of the RACGP Fellowship will be subject to the decision of the RACGP.

(b) CATEGORY II CANDIDATES are doctors who

- 1. are FULLY registered with the Hong Kong Medical Council,
- 2. have been predominantly in general practice in Hong Kong for not less than **five** years by 30 June 2024, provided that the experiences are within the most recent 10 years,
- 3. must be FULL OR ASSOCIATE members of HKCFP at the time of application for the Examination and at the time of the Fellowship Examination.
- 4. had enrolled and passed the Diploma in Family Medicine course organized by the HKCFP, or other equivalent subject to the approval of the Board of DFM, HKCFP.
- 5. had fulfilled the CME/CPD requirements by obtaining both 30 CME points and 10 CPD points accredited by the HKCFP each in the two consecutive years by 30 June 2024.

Please Note:

Starting from 2024, Category II candidates who are eligible to sit for our college exam, will only be awarded FHKCFP upon passing the exam, provided all HKCFP Fellowship requirements are met.

The eligibility of candidates of both categories is subject to the final approval of the Board of Conjoint Examination, HKCFP. Application will not be processed unless all the required documents are submitted with the application form.

(2) FORMAT AND CONTENTS

- **A.** Written Examination consists of (i) Applied Knowledge Test (AKT), and
- (ii) Key Feature Problems (KFP)
- **B.** Clinical Examination
 Clinical Competency Examination (CCE)

(3) PRE-REQUISITE FOR CLINICAL SEGMENTS

All candidates applying to sit for the Clinical Examination of the Conjoint Fellowship Examination MUST possess an APCLS (Advanced Primary Care Life Support) certificate issued by the HKCFP*. The validity of this certificate must cover the time of the Clinical Examination.

Application will not be processed unless the pre-requisite is fulfilled.

*Note: In regarding the APCLS certificate issued by the HKCFP, the APCLS workshops & examinations will be held on 24 March and 28 April 2024 respectively. Please register IMMEDIATELY if you do not hold a valid APCLS certificate issued by HKCFP and intend to sit for the Conjoint Examination 2024.

(4) CRITERIA FOR A PASS IN THE EXAMINATION

A candidate must pass **both** the AKT **and** KFP segments in the Written Examination before one can proceed to the Clinical Competency Examination. Candidates who failed in one segment will be required to re-attempt only the failed segment. Successful Written Examination result can be retained for three years (counting from whenever the first segment is passed). If one fails to pass both segments in three years, one has to retake both segments.

The Clinical Competency Examination can only be taken after passing both segments of the Written Examination. If one fails the Clinical Competency Examination, all the clinical stations have to be re-taken.

A candidate has to pass both the Written and the Clinical Examinations in order to pass the Conjoint HKCFP/RACGP Fellowship Examination.

(5) APPLICATION AND EXAMINATION FEES

Application forms are available from the College Secretariat at Room 803-4, HKAM Jockey Club Building, 99 Wong Chuk Hang Road, Aberdeen, Hong Kong. You may also download the application forms from our College website, http://www.hkcfp.org.hk. Please note that the deadline for application is **11 April 2024 (Thursday)**.

For both CATEGORY I or CATEGORY II CANDIDATES:

Application Fee : \$3,000 (Non-refundable)

Examination Fee: - Full Examination (Written + Clinical) \$36,000

- Written Examination

• AKT \$9,000

• KFP \$9,000

- Clinical Examination \$18,000

Please make the cheque payable to "HKCFP Education Limited". If a candidate applied for the Full Examination but failed in the Written Examination, s/he will be automatically withdrawn from the Clinical Examination, and the Clinical Examination fee (\$18,000) would be refunded.

(6) REFUND POLICY

If a candidate wishes to withdraw from the examination, and written notice of withdrawal is received by the College 60 days or more prior to the date of the examination, he will receive a refund of \$36,000 (for the whole examination), \$9,000 (for AKT), \$9,000 (for KFP) or \$18,000 (for the clinical examination). The application fee of \$3,000 will not be refunded.

No refund will be given if the written notice of withdrawal is received by the College within 60 days of the date of the examination. All fees paid are not transferable to subsequent examinations.

(8) ELECTION TO FELLOWSHIP

Members should be aware that passing the Conjoint Fellowship Examination does NOT equate with election to the Fellowship of either the Hong Kong College of Family Physicians or the Royal Australian College of General Practitioners. Those wishing to apply for Fellowship of either or both College(s) should ensure that they satisfy all the requirements of the College(s) concerned.

Diploma in Family Medicine (HKCFP) 2024 - 2025

The Board is pleased to announce that the Diploma Course in Family Medicine (DFM) organized by The Hong Kong College of Family Physicians will commence in August 2024.

The course consists of FIVE modules. Modules I & II will be delivered by Local Distance Learning. Modules III, IV & V consist of lectures, seminars, tutorials, workshops and clinical attachments. The whole course requires ONE year of part-time study.

Details of the course are as follows:

1. Objectives:

- i) To provide knowledgeable, pragmatic and structured teaching in Family Medicine for medical practitioners
- ii) To encourage professional development of practising medical practitioners and to provide an intermediate step to fellowship qualifications in Family Medicine
- iii) To improve standards and quality in the practice of Family Medicine

2. *Syllabus:

The course consists of FIVE compulsory modules. Doctors who have graduated from the course are expected to have acquired:

- i) Current concepts about nature of Family Medicine
- ii) Knowledge and skills in consultation, counselling and problem solving
- iii) Knowledge and skills in common practice procedures and emergency care required for good quality family practice
- iv) Understandings towards the role of Family Doctors as gatekeepers of the health-care system and in providing cost-effective primary care to the community

Module I – Principles of Family Medicine (Distance Learning)

Aims:	Learn concepts of Family Medicine Understand the role of a Family Doctor and scope of Family Medicine
Contents:	Definition of Family Physicians, Family Physicians' Functions, Core Values of Family Medicine, Consultation, Future of Family Medicine

Module II - Common Problems in Family Medicine (Distance Learning)

Aims:	Enhance consultation, communication and problem solving skills Understand the diagnostic formulation process in Family Medicine
Contents:	Four clinical scenarios. Each clinical scenario is further divided into several questions covering different areas in general practice

*Module III - Essentials of Family Medicine (Structured Seminars and Tutorials)

Aims:	Strengthen knowledge in Family Medicine Understand the potential growth of Family Medicine Develop research and teaching skills in Family Medicine
Content	Practice Management, Care of Elderly, Chronic Disease Management, Anticipatory Care, Clinical Audit & Research, Mental Health, Musculo-skeletal Problems, Evidence Based Medicine & Critical Appraisal

*Module IV - Clinical Updates (Updates and Clinical Attachment)

Aims:	Acquire in-depth knowledge and practical skills in selected specialties	
Contents:	THREE update seminars plus ONE attachment in selected specialty	

*Module V - Practical Family Medicine (Practical Workshops)

Aims:	Enhance practical and communication skills in Family Medicine by Practical Workshops in selected areas including CPR, Consultation Skills, Counselling Skills, Women's Health, Orthopaedic Injection and Musculo-Skeletal Medicine
Contents:	Four compulsory and two elective Practical Workshops in selected areas including Advanced Primary Care Life Support (APCLS), Consultation Skills, Counselling Skills, Women's Health, Orthopaedic Injection and Musculo-Skeletal Medicine

^{*}Modules III - V would be scheduled on Saturday and Sunday afternoons.

3. Articulations:

The Course allows (up to a fixed maximum percentage of the Course units) articulations or cross recognition of previous Family Medicine training programmes that provide learning units equivalent to that of the above syllabus. Participants who wish to apply for such articulations have to submit evidence of relevant training together with their applications. The granting of articulations is however, completely at the discretion and decision of the Board of DFM.

4. *Schedule:

The whole course requires ONE year of part-time study.

5. Admission Requirement:

Registered Medical Practitioner with Bachelor's Degree in Medicine.

6. Teaching Staff:

A panel of experienced academic medical professionals in Family Medicine, hospital specialists and experienced Fellows or Trainers of HKCFP will be invited to teach in the programme.

7. Teaching Medium:

All fees must be paid upon application and before commencement of the course. Fees paid are NON-TRANSFERABLE and NON-REFUNDABLE.

9. Awards/Credits:

- i) A Diploma in Family Medicine issued by HKCFP will be awarded to candidates who have satisfied all the requirements and have passed all the required assessments and the Final Examination.
- ii) The Diploma is a **Quotable Qualification** of the Medical Council of Hong Kong.
- iii) Up to 50 CME and 10 CPD credit points will also be awarded to candidates upon satisfactory completion of the Course by the QA & A Committee of HKCFP.

10. Application Procedure:

Applications are now open.

A completed application form must be returned to The Hong Kong College of Family Physicians with the following:

- i) Photocopy of the current Annual Practising Certificate;
- ii) A recent photo of the applicant (passport size);
- iii) A signed "Disclaimer of Liability";
- iv) An administration fee for application of HK\$1,000 by crossed cheque payable to "HKCFP Education Limited". This fee is non-refundable;
- v) A Course Fee of HK\$45,000 (or HK\$90,000 for non-members) by crossed cheque payable to "HKCFP Education Limited". This fee is non-transferable and non-refundable.

Every successful applicant will be notified by an official letter of admission.

Information and application forms can be obtained from the College or can be downloaded at the College website [http://www.hkcfp.org.hk]. Members who were not admitted in the course in 2023 have to send in their application again if they want to study the course this year. HKCFP CERTIFICATE COURSE IN ESSENTIAL FAMILY MEDICINE 2024-2025

The HKCFP Certificate Course in Essential Family Medicine (CCEFM) is designed to meet the training needs of practicing primary care doctors who would like to refresh or update their clinical knowledge and skills relevant to Family Medicine practice. The curriculum of this course also forms part of the well-established HKCFP Diploma in Family Medicine (DFM) course. Our teaching faculty are experienced clinicians working in primary care, in secondary care and in academia. The course has been designed to enhance the course participants' competencies in daily Family Medicine practice in the community.

1. OBJECTIVES:

- i. To provide knowledgeable, pragmatic and structured training in Family Medicine for medical practitioners
- ii. To encourage professional development of practising medical practitioners
- iii. To improve standards and quality in Family Medicine practice by adopting holistic patient-centered care via an integrated care approach

2 SVII ARIIS

The CCEFM consists of THREE segments, including Modules III, IV (FM attachment + Update) and parts of Module V in the Diploma in Family Medicine (DFM). Doctors who have graduated from the CCEFM are expected to have acquired the following essential concepts and course contents:

- i. The role of Family Doctors particular in providing cost-effective primary care to the community
- ii. The essential knowledge and skills on common problems encountered in Family Medicine
- iii. Enhancement in the consultation and problem solving skills
- iv. Acquiring the knowledge and skills in common practice procedures related to family practice

3. AWARDS/CREDITS:

- i. After completion of all the components and course requirements (max, within TWO years), a certificate will be awarded to the successful candidates
- ii. The completed modules and credits can be accredited towards the quotable HKCFP DFM course, if the candidates would like to enroll into DFM course subsequently
- iii. 25 CME and 5 CPD credit points will also be awarded by HKCFP.

4. COURSE CONTENT:

Segment I - Essentials of Family Medicine (Structured Seminars)

Objectives

- Strengthen knowledge in Family Medicine
- Understand the potential growth of Family Medicine
- ♦ Enable evidence-based Family Medicine practice

Contents:

Anticipatory Care, Elderly Care and related issues, Chronic Disease Management, Common Musculoskeletal Problems, Evidence Based Medicine & Critical Appraisal, Mental Health, Practice Management; and Clinical Audit, Research & Teaching in Family Medicine.

Segment II - Problem Solving and Clinical Updates

Objectives:

- Acquire in-depth knowledge by clinical scenario/simulated cases in our daily Family Medicine practice
- Transfer the practical skills and hand-on experience by interactive learning methods led by Family Medicine Fellows

Contents

A site visit plus scenario based training including Diagnostic Challenges on Common Symptoms, Problem-based Learning on Chronic Disease, Motivational Interviewing, Child Health, Women's Health and Aging and End-of-Life.

Segment III - Practical Family Medicine (Practical Workshops)

Objectives:

- Enhance practical and communication skills in Family Medicine by practical workshops in selected areas
- Transfer the practical skills and hand-on experience by interactive learning methods

Contents:

One compulsory and one elective Practical Workshops in selected areas including Consultation Skills, Counselling Skills, Women's Health, Orthopaedic Injection and Musculo-Skeletal Medicine

5. ADMISSION REQUIREMENTS:

Registered Medical Practitioner with Bachelor's degree in Medicine.

6. TEACHING STAFF:

A panel of experienced academic medical professionals in Family Medicine, hospital specialists and experienced Fellows or Trainers of HKCFP will be invited to teach in the programme.



Beware of Clonorchis Sinensis Infection

As the peak season for travel approaches, many choose to travel abroad, visiting famous landmarks, indulging in shopping, and, of course, enjoying unique and interesting cuisines. The food culture in different regions often differs from that of Hong Kong, and in some places, raw freshwater fish and seafood are used in culinary preparations. Furthermore, some popular media outlets (e.g. TV shows, social media websites, etc.) have recently shared these exotic eating habits, attracting the public to imitate them while traveling. However, consuming raw freshwater fish poses the risk of parasitic infections, especially Clonorchis Sinensis [中華肝吸蟲]. I would like to take this opportunity to refresh everyone's knowledge on the topic.

Clonorchis sinensis, also known as Chinese liver fluke, is a foodborne fluke parasite that primarily infects humans through the consumption of raw or inadequately cooked freshwater fish. The life cycle of this parasite is highly complex and relies on freshwater snails and fish as its transmission chain. The eggs of the parasite, present in contaminated water sources, are ingested by freshwater snails, where they develop into freeswimming larval forms called cercariae. When these larvae come into contact with the skin or flesh of fish in the water, they transform into cystic larvae known as metacercariae. When we consume fish meat that is not thoroughly cooked and contaminated with metacercariae of the Chinese liver fluke, the parasite takes the opportunity to enter our bodies, causing infection. It feeds on nutrients in the human body and settles in the bile ducts of the liver. On the other hand, although some freshwater shrimp serve as a second intermediate host for this fluke, there is currently no epidemiological evidence to prove that they can infect humans with Clonorchis sinensis.

The symptoms of Clonorchis sinensis infection are not always apparent. During the early stages of infection, there may be no obvious symptoms or only mild discomfort. The adult Chinese liver flukes, living in the bile ducts of infected individuals, can survive for 20 to 25 years, leading to a long period without noticeable symptoms. However, in cases of severe and prolonged infection, it can cause symptoms such as loss of appetite, diarrhoea, and fever. More significantly, Clonorchis sinensis can also lead to biliary obstruction and inflammation, increasing the risk of liver diseases such as cirrhosis and cholangiocarcinoma. In fact, the International Agency for Research on Cancer (IARC) has classified Clonorchis sinensis as a Group 1 carcinogen, meaning it is carcinogenic to humans.

One of the diagnostic methods for clonorchiasis is the detection of Clonorchis sinensis eggs or larvae in faecal samples. Serological tests can also be used to diagnose liver fluke infection. For infected individuals, anti-parasitic drugs such as praziquantel are the mainstay of treatment. These medications can kill the adult and larval forms of the parasite, alleviating symptoms and preventing complications. However, post-treatment follow-up may be necessary to ensure complete clearance of the infection.

Clonorchis sinensis is highly prevalent in mainland China, South Korea, Southeast Asia, and other regions. However, cases of this disease have also been reported in non-endemic areas, mostly due to the consumption of undercooked or pickled freshwater fish imported from endemic regions. It has been estimated that over 80% of intestinal parasite infections in Hong Kong are

caused by Clonorchis sinensis. Common carp species, such as grass carp [鯇魚/草魚] and bighead carp [大頭/花鰱/鱅魚], serve as the primary hosts for this parasite. However, it is challenging to identify whether freshwater fish are infected with Clonorchis sinensis because the small cystic larvae are not visible to the naked eye. Therefore, it is crucial to exercise caution, especially when consuming raw, undercooked, salted, pickled, or smoked freshwater fish. Traditional dietary practices popular in southern China, such as freshwater fish sashimi or partially cooked dishes like "crispy grass carp" [「脆肉鯇魚」] or "sliced fish congee" [「生魚片粥」], etc. pose a hidden risk of parasitic infection.

So, how should we remind our patients to prevent Clonorchis sinensis infection? Firstly, we should choose fresh and healthy ingredients and ensure that freshwater fish are thoroughly cooked. It is recommended to slice raw freshwater fish into thin pieces for thorough cooking. The cooked fish meat should turn completely white and easily separate, ensuring that any parasites present are completely killed. In Hong Kong, the sale of Cantonese-style raw fish (freshwater fish sashimi) has been banned for over 30 years (according to the Food Business Regulation, Chapter 132X), indicating the importance of proper cooking. However, when traveling abroad, it is also advisable to avoid consuming raw fish dishes such as sashimi, fish flakes, and other undercooked freshwater fish products. Seasonings such as alcohol, vinegar, mustard, and spices are unable to kill Clonorchis sinensis, so extra attention should be paid to the freshness and thorough cooking of freshwater fish, especially thicker slices that are more difficult to cook through, when used in hot pots and porridge dishes.

In addition, maintaining good hygiene habits is also crucial in preventing infection. Avoid drinking unfiltered or unboiled water. Regular handwashing is one of the fundamental measures, especially after coming into contact with soil, mud, or other items that may be contaminated with parasites. Equally important is the regular cleaning and disinfection of food processing utensils and the environment. It is recommended to use separate utensils for handling raw food and ready-to-eat food to prevent cross-contamination and ensure that parasites cannot thrive and spread. These are important measures to reduce the risk of Clonorchis sinensis infection.

Lastly, we should also take the opportunity to discuss with our patients on the related healthy lifestyle, not only in preventing Clonorchis sinensis infection but also in reducing alcohol intake, avoiding excessive use of medications, maintaining a balanced diet, and engaging in moderate exercise to keep our livers healthy.

Empowering Women's Health: Insights from the MMMC Conference

As a family physician, I recently had the privilege of speaking at the Multi-specialty Medical Mega Conference (MMMC) about abnormal uterine bleeding (AUB). The conference provided a platform for fruitful discussions and knowledge exchange among healthcare professionals, researchers, and experts in the field.

During the conference, I shared our experience from a primary care perspective on AUB. It was an invaluable opportunity for family physicians, gynecologists, radiologists, and pathologists to collaborate and share their thoughts and experiences in managing patients with abnormal uterine bleeding. The discussions encompassed a wide range of topics, including clinical approaches, diagnostic investigations, classification systems, medication options, surgical interventions, embolization techniques, and pathological reporting.


On behalf of the Department of Family Medicine (Kowloon West Cluster), I shared with the audience our approach to handling abnormal uterine bleeding in primary care.

To begin, I presented a case of a 33-year-old woman with irregular menstruation. She is a para 4+1 lady, having had four normal spontaneous deliveries and one surgical termination of pregnancy. She came to us with a one-year history of irregular menstrual flow, with cycle lengths ranging from 12 to 29 days

and durations ranging from 5 days to 2 weeks. On physical examination, her uterus was found to be enlarged to the size of 8-10 weeks of gestation, prompting an ultrasound which revealed a 1.7 x 2.8 cm anterior intramural fibroid. Initial blood tests showed anemia with a hemoglobin level of 10.7.

We initially started her on tranexamic acid and iron supplementation. We also discussed with her the options of hormonal treatment, including the intrauterine device and oral contraceptive pills. The patient opted for the insertion of an intrauterine device (Mirena) as she had no further fertility wishes. This helped manage her heavy menstrual flow and restore her hemoglobin level.

Abnormal uterine bleeding, as defined by the International Federation of Gynecology and Obstetrics (FIGO), refers to deviations from normal menstrual patterns, with normal menses characterized by a frequency of 24 to 38 days, a duration of less than or equal to 8 days, and regularity that is age-dependent. The volume of flow is determined by the patient.



To manage cases of abnormal uterine bleeding, we begin with comprehensive history taking, inquiring about gynecological and systemic symptoms, followed by a thorough examination of the abdomen and a peri-vaginal exam. Based on the findings, we assess the need for further investigations, including baseline hemoglobin level, coagulation

factors, thyroid function, liver and renal function, and hormonal profile. Imaging options such as ultrasound and hysteroscopy can be considered. Tissue diagnosis should be obtained if the woman has risk factors such as age 40 years or older, obesity, a family history of gynecological cancer, a history of unopposed estrogen therapy and tamoxifen use, or if she is unresponsive to medical treatment.

Treatment choices include both non-hormonal and hormonal options. Non-hormonal options such as tranexamic acid and nonsteroidal anti-inflammatory drugs (NSAIDs) are commonly used due to their effectiveness. Hormonal treatment options include the insertion of an intrauterine device, short-term use of cyclic progestin, oral contraceptive pills, and depo-provera injections. Patients with structural lesions should be referred to a gynecologist for surgical intervention.

As a family physician, we should emphasize the prevention of diseases. First, HPV vaccination is important in preventing infection with high-risk strains of HPV that cause cervical cancer. HPV-16, 18, 31, 33, 45, 52, and 58 account for about 90% of cases of cervical cancer. Second, regular surveillance with cervical screening using cytology or HPV testing is useful in promptly detecting early pathological changes and initiating treatment. Lastly, maintaining a healthy lifestyle is of utmost importance in maintaining optimal body weight and reducing the risk of developing gynecological malignancy.

Dr. Samson LAU, gynecologist from Kwong Wah Hospital, then introduced the PALM-COEIN classification of AUB, dividing causes into structural (Polyp, Adenomyosis, Leiomyoma, or Malignancy or hyperplasia) or non-structural (Coagulopathy, Ovulatory dysfunction, Endometrial, latrogenic, Not yet classified). He emphasized that only fibroids which would increase the surface area of the endometrium lining would lead to heavy menstrual flow, including submucosal +/- intramural fibroids. For the treatment approach, it is most effective if it can address the causes of AUB and should be divided into reducing flow and regulating cycles. Referral to a specialist would be warranted for those aged 45 years or older, obesity, known poly cystic ovarian syndrome, severe anemia, or those who do not respond to treatment, etc.

Dr. WONG Sin Man, Radiologist, then introduced the role of uterine artery embolization (UAE) in the management of abnormal uterine bleeding. According to studies, UAE can improve menorrhagia in 83% of patients with fibroids. UAE is more beneficial than traditional myomectomy in terms of shorter hospital stay and faster recovery, but it has a higher re-intervention rate. It is especially helpful for those expecting to reach menopause in 5-10 years' time. Absolute contraindications include pregnancy, active infection, suspected malignancy, uncorrectable bleeding tendency, and refusal of possible hysterectomy. MRI pelvis and MR angiogram (with contrast) are needed before the procedure.

To further enrich the services related to women's health, the Department of Family Medicine (KWC) is in the process of establishing an integrated gynecology clinic. The initial proposal would be to provide care for low-risk women with AUB, oligomenorrhea, and small fibroids. Further possibilities of performing bedside procedures like pipelle and ring pessary insertion would be explored in later phases. This initiative aims to offer timely evaluation and comprehensive management for women diagnosed with gynecological diseases.

LEARNING POINTS FROM BOARD OF EDUCATION

HKCFP 22nd Medical Humanities Interest Group Meeting – 3 February 2024 (Saturday)

Dr. Julie Chen and Dr. Mark Chan

Topic : Medical Humanities in the HKU MBBS

From their earliest clinical exposure, medical students see glimpses of their future –working in a healthcare environment increasingly overtaken by new technology, commercialism and efficiency, which can leave patients (and doctors) lost, unheard and discontented. It is also known that medical students become more cynical and less empathic as they progress through medical school, losing their idealism and sense of connectedness with the patients they serve. To address this, can medical curricula be developed to encourage students to make connections with fellow human beings, allow space for reflection and critical thought, and promote resilience among students as they progress through their undergraduate medical education? Should such initiatives be implemented to support trainees and practising doctors?

A thoughtful and enthusiastic group of doctors participated in this seminar presented by Dr Julie Chen, Director of the Medical Ethics and Humanities Unit (MEHU), Clinical School of Medicine, The University of Hong Kong. We had a stimulating discussion on these questions after hearing about the experience and impact of implementing a novel, compulsory medical humanities (MH) curriculum in the undergraduate MBBS programme at HKU.

While a medical ethics and law curriculum has long been a core part of the MBBS programme, MH was implemented in 2012 to emphasize the humanistic aspect of medicine. Four years of preparation included a literature review, visits to overseas institutions with established MH experience, Faculty staff and student surveys, and piloting elective MH courses. A newly convened multidisciplinary medical humanities planning group conceived the vision around which the curriculum would coalesce: "To deepen the experience of being human, to cultivate humaneness, to be a humanitarian" and oversaw the development of a curriculum with learning outcomes, activities and assessments appropriate for the Hong Kong context.

The resulting MH curriculum is built around 5 broad themes (Doctor and Patient Identities, Culture and Care (including self-care), Living and Dying, History of Medicine and Social Justice and Humanitarianism. It adopts diverse genres and modalities such as narrative, performance arts, film, field trips and experiential learning, to explore the human side of medicine, to enable students to practice critical reflection and to adopt the broad viewpoints and creativity needed to build therapeutic partnerships with their patients in the future. Students read, write, discuss, perform, analyse and create. Their first-year capstone activity is to reflect on one of the themes of the MH programme and create a visual work to express their interpretation. They also learn from the sharing from patients, doctors and people who have insight and experiences that can help them become better doctors.

Students' work demonstrated good reflective capacity and insight into the human condition, and the student evaluations suggested a largely positive response to the MH curriculum which is encouraging. However, the impact of the programme

was most telling when MBBS graduates currently working as Hospital Authority trainees returned during the 10-year MEHU anniversary celebration in May 2023, to participate in panel discussion. They shared how medical humanities infused their day-to-day work, making them more conscious of the need for compassion, empathy and connection with fellow human beings, and actively putting this awareness into practice.

The MH curriculum continues to evolve on the strength of contributing alumni, practising doctors, university teachers, humanities scholars, patients, community members and medical students who partner together who help shape our students into the future doctors we want caring for us and our families.

Moderator Notes

I was with two motives for the meeting, one is to see how our undergraduates are being taught or shown or induced to the subject of medical humanities; secondly, is that I imagine myself back to student days, how would I feel as I go through the session.

It was one of the best sessions I have had in years. Although there were only around 13,14 in the audience.

Yet, who else is more reassuring with Prof Rosie Young sitting in the front seat, giving her 2 hours this Saturday afternoon, to hear what you have done to her students in her University.

And there were 2 Directors of Out Patient Department in private hospitals, one of them has a keen interest in counselling, with his interest being umbrellaed by the first DH consultant in Family Medicine in Hong Kong decades before, pioneered the new counselling training, who was also attending the session.

Then in the back row, we have a retired senior College councillor in his seventies and another doctor who served in the Vietnamese camp 30 years ago. Sitting next to Prof Young was an orthopedic surgeon turned GP serving Sham Shui Po, an area of social inadequacy for the past 35 years.

This composition left the speaker to be the younger member of the group, while the youngest was a college fellow interested in philosophy, reading his Master in the subject.

The consensus was that the attention and resources available in universities was indeed a luxury compared to 30.40 years ago. Sure, there is no hard data to quantify the importance of the subject, decades later, will students be grateful to their well-intended professors' effort?

My thought was that the course was well organised with dedicated teachers, students are in good hands, with guided adventures throughout the 6 years curriculum, arts, movies, role plays, literatures, photo, poems..... perhaps few may aware of the importance of humanitarian elements in their practice in the budding competitive arena, BUT looking at the attendance today, our presence is the testimony of where we placed our most treasured values.


